**SUBJECT: Reconstitution of the Central Office  
Bids and Awards Committee (BAC) for  
Consulting Services**

In the interest of the service and consistent with Republic Act. No. 9184 entitled, "The Government Procurement Reform Act and its Revised Implementing Rules and Regulations (IRR)", the composition of the Central Office Bids and Awards Committee (BAC) for Consulting Services is hereby reconstituted as follows:

The functions of the BAC for Consulting Services shall be in accordance with the relevant provisions of Republic Act No. 9184. It shall continue the unfinished business of the erstwhile BAC for Consulting Services using applicable procurement guidelines.

The regular members of the BAC for Consulting Services shall have a fixed term of one (1) year reckoned from the date of appointment, renewable at the discretion of the Secretary. In cases of resignation, retirement, separation, transfer, reassignment, removal, or death, the replacement shall serve only the unexpired term.

The following shall be invited as observers, who shall sit in and monitor proceedings of the BAC for Consulting Services as Non-Voting Members.

- (a) One (1) Representative from the Commission on Audit (COA)
- (b) One (1) Representative from the Confederation of Filipino Consulting Organizations
- (c) One (1) Representative from a Non-Government Organization (NGO)

The BAC for Consulting Services shall be assisted by the existing Procurement Service that shall serve as the BAC for Consulting Services' Secretariat and have the functions and responsibilities prescribed in Department Order No. 32, series of 2010 and perform other such functions as maybe directed by the Chairman.

All expenses to be incurred including the honoraria/allowances of the personnel involved shall be properly charged against any available funds of the Department, subject to the usual accounting and auditing rules and regulations.

This Order supersedes Special Order No. 159, series of 2015, Special Order No. 147, series of 2014, and Special Order No. 194, series of 2013 and shall take effect immediately.
