

## FORM OF CONTRACT AGREEMENT

THIS AGREEMENT, made this 29<sup>th</sup> day of *December*, 2017 by and between:

*REYNALDO S. ORGANO, MBA, Zone 6, Bantay, Ilocos Sur*, hereinafter called the "Entity,"

and

*PAUL ROVIN MANALAYSAY, Unit G4 #93 Apo St. Barangka Ilaya, Mandaluyong City* hereinafter called the "Consultant."

WHEREAS, the Entity is desirous that the Consultant execute **18CSAC04 SUB – SURFACE EXPLORATION FOR THE CONSTRUCTION OF FLOOD CONTROLS ALONG ABRA RIVER (PHASE I) ABRA RIVER (PHASE II AND 9 OTHERS IN ILOCOS SUR** hereinafter called "the Works," and the Entity has accepted the bid for **One Million One Hundred Eighty Thousand Pesos (Php 1,180,000.00)** by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

  - (i) Performance Security;
  - (j) Notice of Award of Contract and the Bidder's conforme thereto;
  - (k) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.




