Reason/s for Modification

To correct the project name from Mauini-Badduang-Saud-Caparispisan-Balaoi Rd (including Bridges) Ilocos Norte to Maoini-Baduang-Saud-Caparispisan-Balaoi Rd (including Bridges), Ilocos Norte.
There is an urgent need to replace the 1-lane, 60 im. Caunayan Bridge to 2-lanes; 1-lane 18 im. Caparispisan Bridge to 2-lanes and construction of flat slab bridge from 1-barrel box culvert and the inclusion of drainage resulting to a decrease in physical target of the road concreting.

Finding the herein request for modification in order, it is respectfully recommended to the Secretary for his consideration and approval.
