I hereby certify that the **Department of Public Works and Highways, Regional Office V**, has undertaken preliminary activities for Early Procurement Activities (EPA) in accordance with Republic Act No. 9184 and its Implementing Rules and Regulations (IRR), including the preparation and approval of the Terms of Reference (TOR) and the Approved Budget for the Contract (ABC) for Consulting Services. However, prior to the advertisement stage, the original budget under the National Expenditure Program (NEP) was reduced by approximately 89% compared to the General Appropriations Bill (GAB). This significant reduction in funding may result in a failure of bidding, as stipulated under Section 41(c) of RA 9184. Consequently, all feasibility study projects funded under the GAA FY 2025 will be conducted in-house.
