SUBJECT: Creation of a DPWH Turn Over Committee to Facilitate the Implementation of Republic Act No. 11054 on the Organic Law for the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM)

In line with the enactment of Republic Act No. 11054, otherwise known as "An Act Providing for the Organic Law for the Bangsamoro Autonomous Region in Muslim Mindanao, Repealing for the Purpose Republic Act No. 6734, Entitled 'An Act Providing for An Organic Act for the Autonomous Region in Muslim Mindanao," As Amended by Republic Act No. 9054, Entitled "An Act to Strengthen and Expand the Organic Act for the Autonomous Region in Muslim Mindanao," As Amended by Republic Act No. 9054, Entitled "An Act to Strengthen and Expand the Organic Act for the Autonomous Region in Muslim Mindanao," a DPWH Turn Over Committee is hereby created.

The primary functions of this Committee shall include, but not be limited to, the following:

- 1. Prepare a Transfer Plan for Cotabato City District Engineering Office (DEO) pursuant to Section 11, Article XVI, Republic Act No. 11054.
- 2. Coordinate the transfer of permanent personnel of the Cotabato City DEO to the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) in accordance with Section 11, Article XVI, Republic Act No. 11054.
- 3. Implement the transfer of properties, assets, equipments, including unexpended appropriations and allocations, to the Bangsamoro Government and/or DPWH Region XII, as may be applicable, in accordance with the Transfer Plan, Section 11, Article XVI of RA 11054 subject to existing accounting and auditing rules and regulations.
- 4. Implement the transfer of all records of the Cotabato City DEO to DPWH Region XII in accordance with the approved Transfer Plan, Section 11, Article XVI of RA 11054 and the guidelines of the National Archives of the Philippines pertaining to records management.
- 5. Coordinate with the Department of Budget and Management with regards to the creation of plantilla positions for the Regional Project Management Office to be established for the Bangsamoro Autonomous Region.

- 6. Create the necessary Technical Working Group and assign specific duties to its members.
- 7. Such other functions as may be necessary to carry out the provisions of Republic Act No. 11054.

The Committee may call on other officials and employees to assist in the execution of its functions.

This Order shall take effect immediately.
