SUBJECT: Revoking D.O. No. 97, s. 2013,

Disallowing the use of Bid Securing Declaration as Bid

Security

In line with the Government Procurement Policy Board's representation to this Department to implement and allow the use of the Bid Securing Declaration as specifically stated under Section 27.5 of Rule VII, Revised Implementing Rules and Regulations of R.A. 9184 relative to the procurement of infrastructure projects, goods or consultancy services, and in uniformity with other procuring entities of various agencies in the country, D.O. No. 97, series of 2013, is hereby revoked. Strict observance on the use of the prescribed format of Bid Securing Declaration under Appendix 24 of R.A. 9184 (copy attached as Annex "A") is hereby enjoined.

This shall take effect fifteen (15) days after its publication in the Official Gazette or newspaper of nationwide circulation and upon filing with the University of the Philippines Law Center of three (3) certified copies of this order.

BID-SECURING DECLARATION

I/We accept that; (a) I/we will be automatically disqualified from bidding for any contract with any procuring entity for a period of two (2) years upon receipt of your Blacklisting Order; and, (b) I/we will pay the applicable fine provided under Section 6 of the Guidelines on the Use of Bid Securing Declaration¹⁴², if I/we have committed any of the following actions:
 - Withdrawn my/our Bid during the period of bid validity required in the Bidding Documents: or
 - (ii) Fail or refuse to accept the award and enter into contract or perform any and all acts necessary to the execution of the Contract, in accordance with the Bidding Documents after having been notified of your acceptance of our Bld. during the period of bid validity.
- 3. I/We understand that this Bid-Securing Declaration shall cease to be valid on the following circumstances:
 - (a) Upon expiration of the bid validity period, or any extension thereof pursuant to your request:
 - (b) I am/we are declared ineligible or post-disqualified upon receipt of your notice to such effect; and (I) I/we falled to timely file a request for reconsideration or (ii) I/we filed a waiver to avail of said right;
 - (c) I am/we are declared as the bidder with the Lowest Calculated and Responsive Bid/Highest Rated and Responsive Bid143, and I/we have furnished the performance security and signed the Contract.
