SUBJECT: Creation of Prequalification  
Bidding and Awards Committees (PBAC)  
in the Central Office of the Ministry  
of Public Works and Highways.

Pursuant to the implementing rules and regulations, duly approved by the President, of the provisions of PD 1594, and in order to attain a more effective management of prequalification, bidding and awards for public works projects, there are hereby created three Prequalification, Bidding and Awards Committees, the composition of which are as follows:

These Committees shall, likewise, be responsible for the prequalification or short-listing of consulting firms, and the evaluation of proposals for consultancy services, as follows:

- PBAC A - Construction Supervision
- PBAC B - Detailed Engineering
- PBAC C - Planning and Feasibility Studies

In case the consulting service required consists of a combination of any of the above expertise, each Committee will evaluate the portion of the proposal corresponding to its functional responsibility. The financial negotiation shall be made by the Committees concerned in joint session, and the resolution should be signed by all members of the Committees involved in the evaluation.

The members of these committees shall serve for a period not exceeding One (1) year, unless sooner replaced or terminated by the Minister.

To facilitate the processing and preparation of needed documents, as well as to ensure the safekeeping of records of these Committees, the existing secretariats for Prequalification, Bidding and Awards Committee shall continue to function, pending the creation of a new PBAC Secretariat.

All PBAC's under the defunct Ministries of Public Works and Public Highways are hereby deemed abolished.

This Order takes effect immediately.
