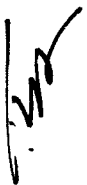

<u>Classification</u>	<u>Limits of Assignment</u>
Materials Engineer II	One project, no cost limit or Two projects located within the same province with an aggregate cost of P10 M but not more than P30 M.
Materials Engineer I	One project costing not more than P100 M or



Three projects located within the same province with an aggregate cost of P1 M but not more than P3 M.

A Certificate of Accreditation and an Identification Card bearing a Permanent Accreditation Number shall be issued to each accredited engineer.
