Series of 1987) the Undersecretaries

Pursuant to Section 8 of Executive Order No. 124, dated 30 January 1987, which reorganized the Department of Public Works and Highways, the following functional areas of responsibility of the Undersecretaries are hereby delineated and assigned:

A. Undersecretary Juanito N. Ferrer:

1. Supervision of operations in Regional Group 1, which covers Regions I, II, III, IV-A, and the National Capital Region, including all Regional Offices, District Offices, Regional Equipment Services, Vitas Fabrication Plant, and Project Management Offices (PMOs) for projects therein.

2. Chairmanship of the central Prequalification, Bids, and Awards Committee (PBAC) for Equipment and Supplies, and supervision of the PBAC Secretariat.

3. Chairmanship of the ad hoc Committee for Staffing and Manning.

B. Undersecretary Fiorello R. Estuar:

1. Supervision of operations in Regional Group 2, which covers Regions IV-B, V, VI, VII, and VIII, including all Regional Offices, District Offices, Regional Equipment Services, and PMOs for projects therein.

2. Supervision of the activities of the Infrastructure Computer Center and associated computer units in the Department.

C. Undersecretary Teodoro G. Gener:

Supervision of operations in Regional Group 3, which covers Regions IX, X, XI, and XII, including all Regional Offices, District Offices, Regional Equipment Services, and PMOs for projects therein.

D. Undersecretary Teodoro T. Encarnacion:

1. Supervision of the Management and Planning Group, which includes the Planning Service, the Comptrollership and Financial Management Service, the Monitoring and Information Service, the Bureau of Research and Standards, the Bureau of Design, and the PMO for Feasibility Studies.

2. Chairmanship of the central Prequalification, Evaluation, and Awards Committee for Consultancy.

E. Undersecretary Jose F. Mabanta:

1. Supervision of the Operations Support Group, which includes the Internal Audit Service, the Legal Service, the Administrative and Manpower Management Service, the Bureau of Construction, the Bureau of Maintenance, and the Bureau of Equipment.

2. Chairmanship of the central PBAC for Construction.

In addition, the Undersecretaries concerned shall exercise their respective delegated authorities for Deputy Ministers as defined in Ministry Order No. 32, dated 27 September 1985.

All heads of the different organizational units of the Department shall be guided by the foregoing in the performance of their respective functions, in their reporting lines, and in the routing of documents.

All Department Orders, Circulars, Memoranda, and other issuances, or parts thereof which are inconsistent herewith are hereby revoked or amended accordingly.

This Order takes effect immediately.
