SUBJECT: Additional/Realignment of Duties
and Areas of Responsibility of
Officials of the Department of
Public Works and Highways

Pursuant to Sections 6 and 37 of Executive Order No. 124 dated 30 January 1987, the following additional duties and functional areas of responsibility of Officials of the Department are hereby delineated and assigned:

I. UNDERSECRETARIES

A. Undersecretary TEODORO G. GENER

1. Supervision of all operations of the fifteen (15) Regional Offices and all operations of the Bureau of Construction, the Bureau of Maintenance, and the Bureau of Equipment.
2. Chairmanship of the Central PBAC for Infrastructure Projects, PBAC for Procurement and Construction/Maintenance Equipment, and PBAC for Procurement of Construction Materials and Supplies, created under Department Order No. 33, s. 1987.

B. Undersecretary TEODORO T. ENCARNACION

Supervision of all operations of the Planning Service, the Bureau of Design, and the Bureau of Research and Standards.

C. Undersecretary JOSE F. MABANTA

Supervision of all operations of the Monitoring and Information Service, the Internal Audit Service, and the Legal Service.

D. Undersecretary ROMULO M. DEL ROSARIO

1. Supervision of all operations of the Project Management Offices (PMOs) in the Department.
2. Chairmanship of the Central PEVAC for Prequalification, Evaluation and Awards Committee (PEVAC) for Consultancy.

E. Undersecretary GREGORIO S. ALVAREZ

Supervision of all operations of the Administrative and Manpower Management Service and the Comptrollership and Financial Management Service.


II. ASSISTANT SECRETARIES

In addition to their present functions and responsibilities in their respective Services, the following Assistant Secretaries shall exercise administrative supervision over the Regional Offices indicated opposite their names:

- A. Asst. Secretary MANUEL M. BONOAN - Regional I, II, III & CAR
- B. Asst. Secretary PROCESO T. GONZALES - Regions IV-A, IV-B, V
& NCR
- C. Asst. Secretary JOSE F. DAVID - Regions VI, VII & VIII
- D. Asst. Secretary RODOLFO V. ROSALES - Regions IX, X, XI & XII

The above-named Officials shall discharge their respective functions and responsibilities in accordance with the Delegation of Authorities provided for in Ministry Order No. 32, s. of 1985, as amended, and Department Order No. 52 dated November 6, 1987, as amended.

This Department order revokes or modifies previous issuances inconsistent herewith and shall take effect immediately.
