All Prequalification, Bidding and Awards T 0: Committees, Bureau and Regional Directors, District and City Engineers, Heads of Attached Agencies, and Others Concerned

To supplement Ministry Order No. 80-31 dated 12 May 1980, the following additional rules and procedures regarding the classification and prequalification of contractors for MPW projects are hereby prescribed:

Under Technical Criteria for Phase I Prequalification l. and Classification of Contractors, add:

"3.2.3 Organization.

"The classification of contractors shall take into account the capability of their respective organization, including the background and experience of key personnel, to execute projects of different types, magnitude and costs.

Under Technical Criteria for Phase II Prequalification, 2. add:

"5.2.4 Organization.

"The adequacy of the organization, including the background and experience of key personnel, that the Contractor intends to use in the execution of the Project to be bid will be considered."

This Order takes effect immediately.

We wish to inform you that we are now about ready to implement six (6) contract packages under our Zonal Improvement Program (ZIP). Salient points on these specific projects are as follows:

Ideally, a Pre-qualification, Bids and Awards Committee (PBAC) should perform all the necessary screening, evaluation and award of contracts. Membership in the Committee shall come from the NHA, MPW, MMC and the local government within whose jurisdiction the subject of the contract is located. The purpose of this letter is to initiate the formation of the PBAC. Just the same, we deem it proper to proceed with implementation notwithstanding the formal creation of the PBAC. We believe that at this stage, immediate project delivery of ready packages should commence to instill and maintain the residents' interests and belief in the goals of our ZIP Program. We trust that you will conform with the position we have taken.

Meanwhile, we shall carry on the task of formally constituting the PBAC. This is in anticipation of other projects that we shall let out in the future.
