

In view of their accreditation, the above-named accredited materials engineers may be assigned to DPWH projects, subject to the following limits of assignment as spelled out under Department Order No. 12, Series of 2013.

<u>Classification</u>	<u>Limits of Assignment</u>
Materials Engineer II	- One (1) project, no cost limit. - Two (2) projects located within the same province for simultaneous assignments, with an aggregate cost of not more than P150M.
Materials Engineer I	- One (1) project costing below P150M. - Four (4) projects located within the same province for simultaneous assignments, with an aggregate cost of not more than P50M.

A Certificate of Accreditation and an Identification Card bearing a Permanent Accreditation Number shall be issued to each accredited engineer.
