SUBJECT: Reclassification of Cebu 4th District Engineering Office (DEO) from 2nd Class DEO to 1st Class DEO

In the interest of the service and in view of the increase in the national equivalent road length of Cebu 4th District Engineering Office for a total of **255.827 kilometers** subsequent to the integration of the gap portion of Dalaguete-Mantalongon Badian Road which was converted into a national road by virtue of D.O. No. 151 series of 2018, pursuant to Item No. 2 of D.O. No. 110, series of 2016, the **Cebu 4th District Engineering Office, Region VII is hereby reclassified from 2nd Class DEO to 1st Class DEO.**

This Order shall take effect immediately.



In the interest of the service and pursuant to the provision of Republic Act No. 11489 dated August 14, 2020 (An Act Creating a District Engineering Office in the Seventh Legislative District of the Province of Cebu and Appropriating Funds Therefor), shall be known as the **Cebu 7th District Engineering Office**, **Region VII**, classified as a Second Class DEO and shall serve the municipalities of Dumanjug, Ronda, Alcantara, Moalboal, Badian, Alegria, Malabuyod and Ginatilan in the 7th Legislative District of Cebu.

The creation of Cebu 7th DEO will result into the downgrading/reclassification of the existing Cebu 4th DEO from First Class DEO into a Second Class DEO and shall comprise of the following municipalities as shown below:

[REPUBLIC ACT NO. 11489]

AN ACT CREATING A DISTRICT ENGINEERING OFFICE IN THE SEVENTH LEGISLATIVE DISTRICT OF THE PROVINCE OF CEBU, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. A district engineering office is hereby created in the Seventh Legislative District of the Province of Cebu, to be located in the Municipality of Dumanjug and referred to as the Seventh District Engineering Office.

SEC. 2. The Seventh District Engineering Office shall serve the municipalities of Dumanjug, Ronda, Alcantara, Moalboal, Badian, Alegria, Malabuyoc and Ginatilan, all located in the Province of Cebu. SEC. 3. The Secretary of Public Works and Highways shall include in the Department's program the operationalization of the Seventh District Engineering Office in the Province of Cebu, the funding of which shall be included in the annual General Appropriations Act.

SEC. 4. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation.
