

DEPARTMENT ORDER) SUBJECT: RECONSTITUTION OF THE
NO. **56** *M* CENTRAL OFFICE PBAC.
Series of 1991 *3/13*

In the interest of the service and corollary to pertinent provisions of Department Order No. 55, dated 21 February 1991, delineating areas of responsibilities of DPWH Undersecretaries, the Central Office PBAC is reconstituted as follows:

- TEODORO T. ENCARNACION Chairman
Undersecretary (For all projects within NCR)
- EDMUNDO V. MIR Chairman
Undersecretary (For all Projects within CAR, Regions I and II)
- JOSE F. MABANTA Chairman
Undersecretary (For all projects within Regions III, IV-A, IV-B and V)
- ROMULO M. DEL ROSARIO Chairman
Undersecretary (For all projects within the Visayas and Mindanao Regions)

The said Committee shall have the following members:

- BIENVENIDO E. MERELOS Member
Assistant Secretary for Legal Service
- FRANCISCO N. PASCUAL Member
Director IV, Bureau of Design
- MANUEL V. MAPA Member
Director IV, Bureau of Construction
- REPRESENTATIVE from the Implementing
Office concerned Member
(Central Office PMO or Regional Office)

In line with the policy of the Department to promote transparency in its operations and pursuant to pertinent provisions of Memo Circular No. 79 of the Office of the President dated October 12, 1988 amending the implementation rules and regulations of P.D. 1594, each PBAC shall have a representative from at least one of the following organizations who shall be a non-voting member:

1. Philippine Institute of Civil Engineers
2. Philippine Constructors Association

3. National Confederation of Constructors Association of the Philippines, Inc.
4. Philippine Institute of Certified Public Accountants

Pursuant to existing rules and regulations, a COA representative shall be invited as witness in every PBAC proceeding.

The PBAC shall be responsible for the prequalification of prospective bidders, conducting the bidding, evaluation of bids and recommending awards of contracts. The Chairman of each PBAC is authorized to sign Invitation for Prequalification and Bidding of projects within their respective areas of responsibility and approve Resolutions for Prequalification and Resolutions of Award for projects costing not more than ₱20,000,000.00.

The Central Office PBAC Secretariat shall serve as the Committee's technical support staff and shall be responsible in the safekeeping of all pertinent documents and records. The Secretariat, thru the PBAC Chairman concerned, is hereby authorized to seek the technical assistance of and/or detail of personnel from various offices of the Department in relation to their assigned tasks.

This Order takes effect immediately and all other orders, circulars, and memoranda inconsistent herewith are hereby modified and/or revoked accordingly.
