**DEPARTMENT ORDER** ) SUBJECT: **OPERATIONALIZATION OF THE CAGAYAN**  
) **DE ORO CITY FIRST DISTRICT**

Pursuant to the provisions of Republic Act No. 9690, dated 04 August 2009, establishing the Cagayan de Oro City First (1<sup>st</sup>) District Engineering Office (DEO), the said DEO is hereby operationalized under the DPWH Region X. Its headquarters shall be located in Barangay Carmen.

The Cagayan de Oro City 1<sup>st</sup> DEO shall comprise the barangays of Carmen, Bulua, Kauswagan, Iponan, Balulang, Canitoan, Lumbia, Patag, Mambuaya, San Simon, Dansolihon, Taglimao, Tagpangi, Bisigan, Bayanga, Tignapoloan, Pigsag-an, Pagalungan, Pagatpat, Tumpagon, Bayabas, Bonbon, Baikingon and Tuburan. The remaining barangays of Macabalan, Puntod, Consolacion, Camaman-an Nazareth, Macasandig, Indahag, Lapasan, Gusa, Cugman, FS Catanico, Tablon, Agusan, Puerto, Bugo, Balubal and all urban barangays from Barangay 1 to Barangay 40 shall remain under the jurisdiction of the existing DEO, which shall henceforth be known as the Cagayan de Oro City 2<sup>nd</sup> DEO.

Pending approval of the DPWH Rationalization Plan, the Cagayan de Oro City 1<sup>st</sup> DEO shall be constituted and manned by appropriate personnel from the Regional Office and/or other offices of the Department as may be identified by the Regional Director of DPWH Region X, subject to approval by appropriate official of the Department, CS Law and Rules and pertinent provisions of the Omnibus Election Code. The DPWH Central Office may also provide technical and planning support to the Cagayan de Oro City 1<sup>st</sup> DEO as may be necessary.

The initial cost to operationalize the Cagayan de Oro City 1<sup>st</sup> DEO shall be charged against appropriate funds of the Department, subject to existing accounting and auditing rules and regulations. Succeeding funding requirements shall be included in the annual budget of the Department.

Supplementary directives may be issued by the Regional Director of DPWH Region X to implement this Order, furnishing the Office of the Secretary with copies thereof.

This Order supersedes previous issuances to the contrary and shall take effect immediately.

[ REPUBLIC ACT NO. 9690 ]

AN ACT ESTABLISHING THE CAGAYAN DE ORO CITY  
FIRST DISTRICT ENGINEERING OFFICE AND  
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:*

SECTION 1. The district engineering office in Cagayan De Oro City, under the supervision of the Department of Public Works and Highways, shall be reconstituted into two (2) separate district engineering offices. The first district engineering office to be located in Barangay Carmen shall be known as the Cagayan De Oro City First District Engineering Office and the existing district engineering office located in Barangay Macabalan shall be known as the Cagayan De Oro City Second District Engineering Office.

SEC. 2. The said Cagayan De Oro City First District Engineering Office shall comprise the barangays of Carmen, Bulua, Kauswagan, Iponan, Balulang, Canitoan, Lumbia, Patag, Mambuaya, San Simon, Dansolihon, Taglimao, Tagpangi, Bisigan, Bayanga, Tignapoloan, Pigsag-an, Pagalungan, Pagatpat, Tumpagon, Bayabas, Bonbon, Bai kingon and Tuburan; while the Cagayan De Oro City Second District Engineering Office shall comprise the remaining barangays of Macabalan, Puntod, Consolacion, Camaman-an Nazareth, Macasandig, Indahag,


Lapasán, Gusa, Cugman, FS Catanico, Tablon, Agusan, Puerto, Bugo, Balubal and all urban barangays from Barangay 1 to Barangay 40.


SEC. 3. The Secretary of Public Works and Highways shall include in the Department's program the operationalization of the Cagayan De Oro City First District Engineering Office, the funding of which shall be included in the annual General Appropriations Act.

SEC. 4. The relevant provisions of Sections 1 and 2 of Republic Act No. 9066, and all other laws, decrees, orders, rules and regulations are hereby modified or amended accordingly.


SEC. 5. This Act shall take effect upon its approval.


