**SUBJECT: AMENDING THE AUTHORITIES AND AREAS OF RESPONSIBILITIES OF UNDERSECRETARY MANUEL M. BONOAN, ASSISTANT SECRETARY JUANITO P. ABERGAS, ASSISTANT SECRETARY RAFAEL C. YABUT AND ASSISTANT SECRETARY RAUL C. ASIS**

In the interest of the service and in view of the retirement of Assistant Secretary Manuel S. Agyao, the authorities and areas of responsibilities of the hereunder officials are hereby amended, as follows:

**U/SEC. MANUEL M. BONOAN** - Relieved of his authorities and areas of responsibilities pursuant to D.O. No. 65 Series of 2005 and all functions provided in other orders issued by this Department. He shall report and receive orders from the Office of the Secretary.

**A/SEC. JUANITO P. ABERGAS** - Shall have overall supervision and control of the Bureau of Maintenance (BOM) and the Operations for Regions I, II, IV-A, V, VI, VII, VIII and CAR, including Project Management Offices (PMOs) under these aforementioned regions, except PMOs performing planning - related functions and PMOs implementing special projects funded by other government agencies. He shall likewise be the Chairman of the Central Office Bids and Awards Committee (BAC) for Civil Works in his area of responsibility.

**A/SEC. RAFAEL C. YABUT** - Shall have overall supervision and control of the Bureau of Equipment (BOE) and the Operations for Regions III, IVB, IX, X, XI, XII, XIII and NCR, including Project Management Offices (PMOs) under these aforementioned regions, except PMOs performing planning - related functions and PMOs implementing special projects funded by other government agencies. He shall likewise be the Chairman of the Central Office Bids and Awards Committee (BAC) for Civil Works in his area of responsibility. He shall also serve as the Department's Legislative Liaison Officer.

**A/SEC. RAUL C. ASIS** - Shall have overall supervision and control of the Planning Service, Bureau of Design (BOD) and Bureau of Construction (BOC) in addition to his duties under D.O. No. 65 Series 2005.

This Order shall take effect immediately. All other orders, circulars, memoranda and issuances inconsistent are hereby amended, modified and/or rescinded accordingly.
