In accordance with Section 21 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, and in line with the principle of transparency and competitiveness, all Invitations to Bid and Requests for Expression of Interest for contracts under competitive bidding shall be advertised by the Procuring Entity in such manner and for such length of time as may be necessary under the circumstances, in order to ensure the widest possible dissemination thereof, such as, but not limited to, posting in the Procuring Entity's premises, in newspapers of general circulation, the PhilGEPS and the website of the Procuring Entity, if available.

All advertisements of the Department, including those of the Regional, District and Sub-District Engineering Offices for Invitation to Bid and Request for Expression of Interest in the Procurement of Civil Works, Consultancy Services and Goods, shall be advertised only in the hereunder newspaper of general circulation which was selected through public bidding, as per Approved Resolution No. G-004-12 dated July 10, 2012. The advertisements shall be published in this official newspaper of the Department for a period of one (1) year from the date of this Order at the prescribed rate below :


