AMENDING DEPARTMENT ORDER NO. 30, SERIES OF 2001, ON AUTHORITY AND RESPONSIBILITY OF UNDERSECRETARIES AND ASSISTANT SECRETARIES, AND OTHER PURPOSES

In the interest of the service and pursuant to Sections 6 and 37 of Executive Order No. 124 dated 30 January 1987, the authorities and areas of responsibilities of Undersecretaries and Assistant Secretaries are hereby amended as follows:

- Undersecretary EDMUNDO V. MIR is hereby designated as the Undersecretary for Design, Construction, Maintenance and Equipment. He shall have overall supervision of the Bureaus of Design, Construction, Maintenance and Equipment, Project Management Offices tasked to implement maintenance related projects, the maintenance operations of Regional and District Engineering Offices, and the Bids and Awards Committee (BAC) - Technical Working Group at the Central Office. He shall serve as Chairman of the BAC for Civil Works at the Central Office. Furthermore, he shall perform such other assignments as may be given by the Secretary from time to time.
- Undersecretary TEODORO T. ENCARNACION is hereby designated as the Undersecretary for Planning and Related Services. He shall have overall supervision of the Planning Service, Monitoring and Information Service, Bureau of Research and Standards, Legislative Liaison Office and Project Management Offices (PMOs) tasked to undertake planning and project studies. He shall serve as the Chairman of the Pre-Qualification, Evaluation and Awards Committee (PEAC) for Consultancy Services at the Central Office. Furthermore, he shall perform such other assignments as may be given by the Secretary from time to time.
- Undersecretary MABINI F. PABLO is hereby designated as the Undersecretary for Finance and Administrative Services. He shall have overall supervision of the Administrative and Manpower Management Service (AMMS), Comptrollership and Financial Management Service (CFMS) and Legal Service. He shall be assisted by the Assistant Secretary in charge of the CFMS and Legal Service. Furthermore, he shall perform such other assignments as may be given by the Secretary from time to time.
- Undersecretary MANUEL M. BONOAN is hereby designated as the Undersecretary who shall have overall supervision of construction operations of the Department covering both foreign assisted and locally-funded projects, to be assisted by the three Assistant Secretaries for Operations, namely: Jesus P. Cammayo, Bashir D. Rasuman and Florante M. Soriquez. He shall also exercise supervision over construction operations in the National Capital Region and Regions VI, VII and VIII. He shall likewise have administrative supervision over all Project Management Offices performing construction functions. Furthermore, he shall perform such other assignments as may be given by the Secretary from time to time.
- Assistant Secretary JESUS P. CAMMAYO is hereby designated as the Assistant Secretary who shall have supervision of construction operations for foreign assisted and locallyfunded projects in Regions I, II, IV-A and the Cordillera Administrative Region. Furthermore, he shall perform such other assignments as may be given by the Secretary from time to time.

- Assistant Secretary BASHIR D. RASUMAN is hereby designated as Assistant Secretary who shall have supervision of construction operations for foreign assisted and locally-funded projects in Regions IX, X, XI, XII, XIII and the Autonomous Region of Muslim Mindanao. Furthermore, he shall perform such other assignments as may be given by the Secretary from time to time.
- Assistant Secretary FLORANTE M. SORIQUEZ is hereby designated as Assistant Secretary who shall have supervision of construction operations for foreign assisted and locallyfunded projects in Regions III, IV-B and V. Furthermore, he shall perform such other assignments as may be given by the Secretary from time to time.
- Assistant Secretary JOEL L. ALTEA is hereby designated as the Assistant Secretary who shall have direct supervision of the Comptrollership and Financial Management Service and the Legal Service. He shall also serve as Chairman of the BAC for Supplies, Materials and Equipment at the Central Office. Furthermore, he shall perform such other assignments as may be given by the Secretary or Undersecretary from time to time.

The Internal Audit Service and the Public Information Office shall be directly under the Secretary,

The above-mentioned authorities and functions shall be performed in accordance with the provisions of Department Order No. 42, Series of 1988, as amended, and other pertinent issuances.

This Order shall take effect immediately, and all other orders, circulars and memoranda or parts thereof inconsistent herewith are hereby revoked and/or modified accordingly.
