**SUBJECT: CREATION OF COMMITTEE ON
THE RELOCATION/TRANSFER
AND FACILITIES IMPROVEMENT
OF DPWH OFFICES AND ITS
TECHNICAL WORKING GROUP
(TWG)**

In order to facilitate the immediate systematic and cost effective relocation and transfer of the DPWH Offices to a new government site and to review, oversee/ monitor the repair, rehabilitation and/or improvement of office facilities of various DPWH Offices, a DPWH Committee and its Technical Working Group (TWG) are hereby created to plan, coordinate and negotiate the said transfer and to evaluate the Detailed Estimate and Program of Work of any construction/repair projects for office facilities improvement. The Committee shall be composed of the following:

Chairman : Undersecretary for Support Services
Vice Chairman : Assistant Secretary for Support Services
Members : Assistant Secretary for Regional Operations Concerned
Director, Bureau of Design
Regional Director Concerned
Director, Human Resource and Administrative Service
Director, Planning Service
Director, Financial and Management Service
Project Director Concerned

The Committee shall handle all relocation and transfer of offices. It shall undertake identification and acquisition of site including documentation and the conduct of necessary consultation with concerned local officials or private sectors. The Committee shall oversee the preparation of site development plans which includes the construction/renovation and improvement of new DPWH building/offices and housing facilities for affected employees, the identification of available funding and support services, and eventual transfer of personnel, records, office equipment, furniture, supplies and other properties of the concerned office. Furthermore, the Committee shall also monitor facilities improvement in the DPWH Central Office and all other DPWH offices outside the Central Office shall submit for

the Committee's information, copies of plans, detailed estimates, programs of work of any construction/repair projects for office facilities improvement.

The Committee Chairman and Vice-Chairman are hereby authorized to attend the inter-agency meeting concerning the said transfer and shall give status report to the Secretary.

The Committee shall be assisted by a Technical Working Group (TWG) to be composed of the following:

TECHNICAL WORKING GROUP:

- Head : Assistant Director, Bureau of Design
- Members : Chief, Facilities Maintenance Division - HRAS
Chief, Supply & Property Management Division - HRAS
Chief, Construction Support Services Division - BOC
Representative- Bureau of Design (Buildings Division)
Representative- Unified PMO (Buildings & Special Projects Management Division)
Representative- Financial and Management Service
Representative- Planning Service
Representative- Legal Service
Representative- Concerned Office
President, DPWH Employees' Union

The TWG shall evaluate and review the Detailed Estimates and Program of Work of the proposed repair/improvement of various DPWH office buildings and facilities and shall make appropriate recommendations to the Committee. The TWG shall likewise oversee/monitor the on-going office repair/maintenance projects.

All officials and employees of this Department are hereby directed to provide the necessary assistance and cooperation to the Committee/TWG in the successful accomplishment of their tasks.

This Order supersedes D.O. No. 17, s. 2014 and shall take effect immediately.
