

SUBJECT: TIME TABLE/DEADLINES RELATIVE TO D.O. NO. 2, SERIES OF 2001 ON GUIDELINES IN THE ELIGIBILITY PROCESSING OF CONTRACTORS FOR CIVIL WORKS PROJECTS.

In order for contractors to have sufficient time to prepare and submit their application for registration and application for eligibility to bid for specific projects and also for the DPWH to process contractor's registration and eligibility as well as issue bid documents, it is hereby directed that the following time table/deadlines relative to the Department Order No. 2, Series of 2001 be observed and strictly adhered to viz:

## Activities

Application for Contractor's Registration to DPWH BAC-TWG Office before intending to participate in the bidding.

Contractor's appeal for correction or upgrading of the Registration of Contractor's Information Report from BAC-TWG Office.

Submission of Contract Profile for Eligibility Processing (Form NR-002) by Implementing Office to BAC-TWG Office.

#### **Deadlines**

At least 1 month.

7 CD upon receipt.

At least 10 CD before its 1<sup>st</sup> day of advertisement.

Letter of Intent of Contractors to participate to bid in Implementing Office/BAC-TWG office.

Submission in one batch of interested bidders by Implementing Office to BAC-TWG Office on Expression of Interest for Eligibility Processing (Form NR 003).

Issuance of Plans and Tender Documents by Implementing Office to bidders.

Central BAC-TWG Office inform Implementing Office/Bidders on results of Eligibility Statement Reports.

Appeal of Ineligible Bidders to bid from Central BAC-TWG Office.

Deadline for the submission of bidder's Eligibility Statement Report (Form NR 003) to bid in order to purchase bid documents at the Implementing Office. Within the advertisement period or 14 to 21 CD.

At least 5 CD after last day of advertisement.

At least 12 CD.

5 CD after submittal of Form NR 003 to BAC-TWG Office.

7 CD upon receipt.

Within 10 days from the 1<sup>st</sup> day of issuance of the bidding documents.

Attachment 1 and 2 in this D.O. are the revised Form NR 002 and Form NR 003, which should be completely filled up when submitting to BAC-TWG Office. Activity 5 to activity 14 of attachment 3 is a Time Table Guide, which is useful in preparing procurement schedule by the Implementing Office.
