In the interest of the service and pursuant to Sections 6 and 37 of Executive Order No. 124 dated 30 January 1987, the authorities and areas of responsibilities of Undersecretaries and Assistant Secretaries are hereby amended as follows:

Undersecretary MANUEL M.
BONOAN -

is hereby designated as the Undersecretary for Technical Services and Bureaus. He shall have overall supervision and control of the Planning Service (PS), Monitoring and Information Service (MIS), Project Management Offices performing Planning related functions, overall administrative supervision over all Project Management Offices performing Civil Works functions, and overall supervision and control over all Bureaus. He shall be assisted by Assistant Secretary RAUL C. ASIS. Furthermore, he shall perform such other assignments as may be given by the Secretary from time to time.

Undersecretary ANTONIO A.
INOCENTES -

seconded from SBMA, is hereby designated as the Undersecretary for Administration and Finance. He shall have overall supervision and control of the Administrative and Manpower Management Service (AMMS), Comptrollership and Financial Management Service (CFMS), Legal Service, BAC-TWG and PEAC-TWG. He shall serve as Chairman of the Central Office BAC for Civil Works. He shall serve as the Chairman of the Central Office Pre-Qualification, Evaluation and Awards Committee (PEAC) for Consulting Services. He shall serve as Chairman of the Central Office BAC for Supplies, Materials and Equipment. Furthermore, he shall perform such other assignments as may be given by the Secretary from time to time.

Undersecretary FLORANTE M.
SORIQUEZ -

is hereby designated as the Undersecretary for Operations - Area 1, in-charge of overall supervision and control over project implementation in Regions I, II, CAR, III, and NCR. He shall be assisted by Assistant Secretary MANUEL S. AGYAO. Furthermore, he shall perform such other assignments as may be given by the Secretary from time to time.

Undersecretary SALVADOR A.
PLEYTO -

is hereby designated as the Undersecretary for Operations - Area 2, in-charge of overall supervision and control over project implementation in Regions IV-A, IV-B, V, VI, VII, and VIII. He shall be assisted by Director RAFAEL C. YABUT. Furthermore, he shall perform such other assignments as may be given by the Secretary from time to time.

Assistant Secretary BASHIR D.
RASUMAN -

is hereby designated as the Assistant Secretary for Operations - Area 3, in-charge of overall supervision and control over project implementation in Regions IX, X, XI, XII, XIII. He shall be assisted by Director MOCAMAD M. RAKI-IN, Sr. Further, he shall perform such other assignments as may be given by the Secretary from time to time.

Assistant Secretary MANUEL S. -
AGYAO

is hereby designated as the Assistant Secretary for Operations - Area 1. Furthermore, he shall perform such other assignments as may be given by the Secretary or Undersecretary from time to time.


Assistant Secretary RAUL C. ASIS -
