## SUBJECT: AMENDING THE AUTHORITIES AND AREAS OF RESPONSIBILITIES OF DPWH KEY OFFICIALS

In the interest of the service and pursuant to the pertinent provisions of E.O. No. 124, s. 1987, and in view of the approval of DPWH Rationalization Plan pursuant to E.O. No. 366, s. 2004, the authorities and responsibilities of DPWH Undersecretaries and Assistant Secretaries are hereby amended as follows:
