The District Level Focal Persons or their designated representative should coordinate with their counter part Focal Person at the National Anti Poverty Commission (NAPC), the Rural Development Executives and the DILG's Local Poverty Reduction Action Offer (LPRAO), consolidate the needs/issues of the barangays/ communities within their territorial jurisdiction and respond to the identified needs/problems/concerns of the targeted communities, if within DPWH mandate. Inform this office, thru the DPWH Focal Person, of the action taken and its result.

In support to the DPWH Focal Person, Engr. Edilberto D. Tayao and Ms. Benedicta L. Protesta, Asst. Regional Director and Management Audit Analyst III, both of the NCR, are hereby directed to provide technical and administrative functions, respectively, particularly in the project programming, scheduling, coordination and submission of reports for all activities relative to KALAHÍ.
