SUBJECT: Amendment to Department Order No. 79, Series of 1995, Relative to the Issuance of Certificate of Completion and Certificate of Acceptance

To ensure that the final inspection and acceptance and the corresponding maintenance of DPWH projects will be carried out more effectively by the concerned units and personnel of this Department, the composition of the Inspectorate Team as provided under item "a" of Department Order No. 79, Series of 1995, is hereby amended to read as follows:

"a." For projects undertaken by the Central Office Project Management Offices (PMO's)/Implementing Offices: one representative each from the Bureau of Design, the Bureau of Construction, the Bureau of Maintenance, the Bureau of Research and Standards, the Implementing Office, the Regional Office and the **concerned District Engineering Office (DEO)**. Representatives of the above-mentioned Bureaus and Concerned Regional Office must be regular members of the Quality Assurance Units. **Representative from the concerned District Engineering Office must likewise be a regular member of the Quality Assurance Units or Project Engineer accredited by the DPWH.**"

Except for the above amendment the other guidelines as provided under Department Order No. 53 Series of 1994 as amended by Department Order No. 81 Series of 1994 and Department Order No. 79 Series of 1995, shall remain to be enforced.
