SUBJECT: Amending the Legislative Districts of the Province of Bataan, subsequent to the Creation of one (1) New Additional Legislative District per R.A. No. 11553

In the interest of the service and pursuant to implementation of Republic Act No. 11553 "**An Act Providing for the Reapportionment of the Province of Bataan into three (3) Legislative Districts**", the Legislative Districts of the component municipalities of Bataan 1st and 2nd DEOs are hereby amended in accordance with the above-mentioned law to ensure consistency with the Operating Unit in the General Appropriations Act (GAA) and handle data migration in all affected computer applications as well as paper records for finance and procurement.
