SUBJECT: DELINEATION/REALIGNMENT OF
AREAS OF RESPONSIBILITY
OF DPWH UNDERSECRETARIES

Pursuant to Sections 6 and 37 of Executive Order No. 124 dated 30 January 1987, the following duties and functional areas of responsibility of Undersecretaries of this Department are hereby delineated and assigned:

I. OPERATIONS

1. Undersecretary JOSE F. MABANTA

Supervision of all operations of Regions I, CAR, II, III, NCR, IV-A, IV-B and V (Luzon).

2. Undersecretary EDMUNDO V. MIR

Supervision of all operations of Regions VI, VII, VIII, IX, X, XI and XII (Visayas and Mindanao).

3. Undersecretary ROMULO M. DEL ROSARIO

Supervision of all operations of Project Management Offices (PMOs).

II. SUPPORT SERVICES

1. Undersecretary TEODORO T. ENCARNACION

Supervision of all operations of the Planning Service, Bureau of Design, Bureau of Construction, Bureau of Maintenance, and Bureau of Research and Standards (Technical Services).

2. Undersecretary GREGORIO S. ALVAREZ

Supervision of all operations of the Administrative and Manpower Management Service, Comptrollership and Financial Management Service, Legal Service, Monitoring and Information Service, and Internal Audit Service (Finance and Administration Services).

3. Undersecretary JOSE F. MABANTA

Supervision of all operations of the Bureau of Equipment on interim basis.

III. SPECIAL ASSIGNMENTS

- a. Chairmanship of the Central Prequalification, Bids and Awards Committee (PBAC) for Construction for Luzon projects, including materials and equipment to be directly integrated into construction projects.

- b. DPWH representative to the Cabinet Assistance System (CAS).


