

In the interest of the service and pursuant to Sections 6 and 37 of Executive Order No. 124 dated 30 January 1987, the authorities and areas of responsibilities of Undersecretaries and Assistant Secretaries are hereby amended as follows:

Undersecretary MANUEL M. BONOAN

shall have overall supervision and control of the Planning Service (PS), Monitoring and Information Service (MIS), and Project Management Offices (PMOs) performing Planning related functions, and overall administrative supervision over all Project Management Offices performing Civil Works functions. He shall likewise be the Chairman of Central Office Pregualification and Awards Committee (PEAC) for Consultancy. He shall continue to be the Project Implementation Officer for **ODA**-assisted projects implemented by the Department.

Undersecretary SALVADOR A. PLEYTO

is hereby designated as the Undersecretary for Operations for Regions I, II, CAR, VI, VII and VIII. He shall serve as the Chairman-Bids and Awards Committee (BAC) in his area of responsibility.

Undersecretary BASHIR D. RASUMAN

is hereby designated as the Undersecretary for Operations for Regions IX, X ,XI, XII, and XIII. He shall serve as the Chairman-Bids and Awards Committee (BAC) in his area of responsibility. p.2

Undersecretary ANTONIO A. INOCENTES

shall have overall supervision and control of the Administrative and Manpower Management Service (AMMS), and the Legal Service.

Assistant Secretary MANUEL S. AGYAO

shall have overall supervision and control of the Bureau of Construction (BOC), Bureau of Maintenance (BOM), and Bureau of Equipment (BOE). He shall serve as Chairman-BAC for Construction/Maintenance Materials and Equipment.

Assistant Secretary RAUL C. ASIS

shall have overall supervision and control of the Comptrollership and Financial Management Service (CFMS), in addition to assisting Undersecretary Manuel M. Bonoan in the Planning Service.

Assistant Secretary MOCAMAD M. RAKI-IN. SR.

shall have overall supervision and control of the Bureau of Design (BOD), Bureau of Research and Standards (BRS). He shall serve as Chairman-BAC for Office Supplies and Equipment.

Assistant Secretary RAFAEL C. YABUT

shall have overall supervision and control of the Operations for Regions III, IV-A, IV-B, V, and the NCR. For this purpose, he shall be reporting directly to Secretary. He shall serve as the Chairman-Bids and Awards Committee (BAC) in his area of responsibility. D.O. NO. 114 S.2003 p.3

The Internal Audit Service and the Public Information Division shall continue to be directly under the Office of the Secretary.

The above-mentioned authorities and functions shall be performed in accordance with the provisions of Department Order No. 42, series of 1988, as amended, and other pertinent issuances.

This order shall take effect immediately, and all other orders, circulars, and memoranda inconsistent herewith are hereby modified and/or revoked accordingly.
