BEING CONDUCTED BY THE
DPWH CENTRAL, REGIONAL AND
DISTRICT OFFICES

Pursuant to the provisions of Section 13.1 of the Implementing Rules and Regulations (IRR-A) of RA No. 9184, otherwise known as the Government Procurement Reform Act, and to further enhance transparency in the Department's procurement process, all Bids and Awards Committees (BACs) in the DPWH Central, Regional and District Offices shall each invite at least one representative from any of the registered NGOs in their respective areas to sit as observer(s) in all stages of the procurement process, i.e., pre-bid conference, opening of bids, postqualification, contract award and special meeting(s) of the BAC.

A list of NGOs with trained representatives is hereto attached as Annex A, from which the BAC may select the NGOs they will invite to participate in the procurement process. The said list shall be updated by the Central Office BAC Technical Working Group (TWG) at least once every semester in coordination with the Procurement Watch, Inc. which has been authorized to conduct trainings on the IRR-A of RA No. 9184 for NGO representatives. The Regional and District Offices shall submit to the Central Office BAC-TWG their respective recommendations in the periodic updating of the list.

In areas where there are no registered NGOs, the BAC concerned may invite NGO representative(s) from the nearest locality where there is/are NGO representative(s) available based on the updated list of NGOs with trained representatives.

This Order shall take effect immediately.
