SUBJECT: AMENDING THE AUTHORITIES AND AREAS OF RESPONSIBILITIES OF DPWH KEY OFFICIALS

In the interest of the service and pursuant to the pertinent provisions of E.O. No. 124, s. 1987, and in view of the approval of DPWH Rationalization Plan pursuant to E.O. No. 366, s. 2004, the authorities and responsibilities of DPWH Undersecretaries and Assistant Secretaries are hereby amended as follows:

Undersecretary
RAUL C. ASIS

- Shall serve as Undersecretary for Technical Services and as such shall have overall supervision and control over all the Bureaus.

Undersecretary
ROMEO S. MOMO

- Shall serve as Undersecretary for Regional Operations. He shall have overall supervision and control over the Operations of all Regional Offices of the Department.

Undersecretary
RAFAEL C. YABUT

- Shall serve as Undersecretary for Unified Project Management Office (UPMO) operations and as such shall have overall supervision and control over the operations of the five (5) specialized clusters under UPMO.

JAIME A. PACANAN

- Shall serve as Undersecretary for Support Services and as such shall have overall supervision and control over the Human Resource and Administrative Service (HRAS), Financial and Management Service (FMS), Information Management Service (IMS), Legal Service, Procurement Service and Stakeholders Relations Service.

Undersecretary
ALFREDO G. TOLENTINO

- Shall serve as Undersecretary who shall have overall supervision and control over all infrastructure projects to be implemented by DPWH but funded under the budget of various line agencies, i.e., school buildings, health centers, and farm-to-market roads.

MARIA CATALINA E. CABRAL

- Shall serve as Undersecretary for Planning Service and the Public-Private Partnership Service. The Legislative Liaison Staff shall also be under her direct supervision.

**Assistant Secretary
EUGENIO R. PIPO, JR.**

- Shall serve as Assistant Secretary for Regional Operations in Luzon. He shall assist the Undersecretary for Regional Operations in the overall supervision and control of Regions I, II, III, IV-A, IV-B, V, CAR and NCR.

**Assistant Secretary
DIMAS S. SOGUILON**

- Shall serve as Assistant Secretary for Regional Operations in Visayas and Mindanao. He shall assist the Undersecretary for Regional Operations in the overall supervision and control over Regions VI, VII, VIII, IX, X, XI, XII and XIII.

**Assistant Secretary
ARDELIZA R. MEDENILLA**

- Shall serve as Assistant Secretary for Support Services. She shall assist the Undersecretary for Support Services in the overall supervision and control over the HRAS, FMS, IMS, Legal Service, Procurement Service and Stakeholders Relations Service.

**Assistant Secretary
GILBERTO S. REYES**

- Shall serve as Assistant Secretary for Technical Services. He shall assist the Undersecretary for Technical Services in the overall supervision and control over all the Bureaus.

The **Internal Audit Service** shall be under the direct supervision and control of the Office of the Secretary.

This Order supersedes Department Order No. 131, s. 2014, and all other issuances inconsistent herewith, and shall take effect immediately.
