

**DEPARTMENT ORDER** ) SUBJECT: Amending the Authorities and Areas of **Responsibilities of DPWH Key Officials** 

In the interest of the service and pursuant to the pertinent provisions of E.O No. 124 s. 1987 and in view of the approval of DPWH Rationalization Plan pursuant to E.O. No. 366, s. 2004, the authorities and responsibilities of DPWH Undersecretaries and Assistant Secretaries are hereby amended as follows:

Senior Undersecretary RAFAEL C. YABUT	Shall serve as Undersecretary for Regional Operations in Visayas and Mindanao. He shall have overall supervision and control over the operations of all Regional Offices in Visayas and Mindanao. He shall likewise have overall supervision and control over all infrastructure projects implemented by this Department but funded under the budget of various line agencies, i.e. school buildings, health centers and farm-to-market roads in his areas of assignment.
Undersecretary ROMEO S. MOMO	Shall serve as Undersecretary for Regional Operations in Luzon. He shall have overall supervision and control over the operations of all Regional Offices in Luzon. He shall likewise have overall supervision and control over all infrastructure projects implemented by this Department but funded under the budget of various line agencies, i.e. school buildings, health centers and farm-to-market roads in his area of assignment.
Undersecretary RAUL C. ASIS	Shall serve as Undersecretary for Technical Services and as such shall have overall supervision and control over all the Bureaus.
Undersecretary MARIA CATALINA E. CABRAL	Shall serve as Undersecretary for Planning Service and the Public-Private Partnership Service.
Undersecretary ARDELIZA R. MEDENILLA	Shall serve as Undersecretary for Support Services and as such shall have overall supervision and control over the Human Resource and Administrative Service (HRAS), Financial Management Service (FMS), Information Management Service (IMS), Legal Service, Procurement Service and Stakeholders Relations Service.

Undersecretary EMIL K. SADAIN	Shall serve as Undersecretary for Unified Project Management Office (UPMO) operations and as such shall handle the overall administrative functions of the five (5) specialized clusters of the UPMO. The operations of the four (4) UPMO Clusters, namely, Bridges Management Cluster, Roads Management Cluster 1, Roads Management Cluster 2 and Buildings Management Cluster, shall remain under his overall supervision,
Assistant Secretary EUGENIO R. PIPO, JR.	Shall serve as Assistant Secretary for Regional Operations in Luzon. He shall assist the Undersecretary for Regional Operations in the overall supervision and control of Regions I, II, III, IV-A, IV-B, V, CAR, and NCR.
Assistant Secretary ROBERTO R. BERNARDO	Shall serve as Assistant Secretary for Regional Operations in the Visayas. He shall assist the Undersecretary for Regional Operations in the overall supervision and control over Regions VI, VII, VIII and NIR.
Assistant Secretary DIMAS S. SOGUILON	Shall serve as Assistant Secretary for Regional Operations in Mindanao. He shall assist the Undersecretary for Regional Operations in the overall supervision and control over IX, X, XI, XII and XIII.
Assistant Secretary GILBERTO S. REYES	Shall serve as Assistant Secretary for Technical Services. He shall assist the Undersecretary for Technical Services in the overall supervision and control over all the Bureaus.
Assistant Secretary B. ELIZABETH E. YAP	Shall serve as Assistant Secretary for Support Services. She shall assist the Undersecretary for Support Services in the overall supervision and control over the Human Resource and Administrative Service (HRAS), Financial Management Service (FMS), Information Management Service (IMS), Legal Service, Procurement Service and Stakeholders Relations Service.

The oversight functions over the Flood Control Management Cluster under the UPMO shall be shared by the Undersecretaries for Regional Operations based on their areas of assignment with the Undersecretary for UPMO Operations as defined in D.O. 87, s. 2016.

The **Internal Audit Service** shall be under the direct supervision and control of the Office of the Secretary.

This Order supersedes Department Order No. 100, series of 2016, and all other issuances inconsistent herewith, and shall take effect immediately.
