The Steering Committee shall provide overall guidance and supervision on the conduct of the said revision/updating, and shall evaluate and submit the recommendations of the Technical Committee, for approval of the Secretary.

The Technical Committee shall have the following responsibilities:

- a. Identify the areas of the existing design guidelines, criteria and standards that need to be revised/updated.
- b. Identify and evaluate current accepted design innovations and technologies that may possibly be adopted in the implementation of infrastructure projects.
- c. Set the minimum and acceptable limits as basis for ideal, efficient and economical design for all infrastructure projects.
- d. Recommend revised/new guidelines, criteria and standards to the Steering Committee for approval of the Secretary.

The Secretariat will serve as the coordinating and monitoring unit of the Technical Committee.

The Chairman is authorized to seek technical assistance and services that are deemed necessary for these Committees to carry out their tasks effectively.

This Order shall take effect immediately.
