**SUBJECT: SPECIAL BAC FOR Civil Works and
Consultancy Services for Public-Private
Partnership (PPP) Projects**

Pursuant to the provisions of the Implementing Rules and Regulations of RA 6957, as amended by RA 7718 (BOT Law)), the qualification, bidding and recommendation for award of the *civil works* and *PPP related consultancy services* (Feasibility Study, Business Case Study, procurement of Independent Consultant) contract for all PPP Projects shall be undertaken by the Special BAC for Civil Works and Consultancy to be composed of the following:

A Technical Working Group (TWG) is also hereby constituted to undertake the preliminary evaluation of the qualification documents and bids and shall submit the results to the aforementioned Special BAC for review and recommendation to the Secretary. The TWG shall compose of the BOT-PMO, as Head, and a representative each from BOT-PMO, Procurement Office for Civil Works (POCW) or BAC for Consultancy, Bureau of Design, Bureau of Construction, and Feasibility Study-PMO, representative from the concerned regional office as members. The SBAC may invite other offices when necessary. The BOT-PMO shall act as the Secretariat to the BAC.

This Order amends Special Order Nos. 68 and 117, both series of 2011 and shall take effect immediately.
