SUBJECT: RECONSTITUTION OF THE BOARD OF
CONSULTANTS OF THE NATIONAL
BUILDING CODE

In the interest of the service, the composition of the Board of Consultants (BoC) of the National Building Code (NBC) under Special Order No. 66, series of 2007, dated May 28, 2007 is hereby reconstituted as follows:

The reconstituted BoC-NBC members shall be composed of the representatives of the following agencies and organizations:

12. Philippine Institute of Volcanology and Seismology (PHIVOLCS)
13. Philippine Society of Mechanical Engineers (PSME)
14. Philippine Society of Sanitary Engineers (PSSE)
15. Professional Regulation Commission (PRC)
16. United Architects of the Philippines (UAP)

The BoC-NBC shall assist the DPWH National Building Code Development Office (NBCDO) in undertaking the following continuing activities:

1. Review of the National Building Code of the Philippines (PD 1096) and identify the provisions that need updating/amendments;
2. Study of the proposed amendments to the NBC including its Implementing Rules and Regulations (IRR) submitted by various

- sectors and provision of technical expertise to Congress in aid of legislation;
3. Review of the existing NBC Circulars and other related issuances of the Department and recommend appropriate amendments thereof;
 4. Assistance in the technical evaluation of NBC cases and inquiries as requested; and
 5. Other NBC related activities as maybe directed by the Secretary.

The Board shall be assisted by a Secretariat to be composed of the following personnel:

1. Engr. Nonie A. Viyar (Bureau of Research and Standards)
2. Engr. Olinar B. Mangubat (Bureau of Construction)
3. Engr. Ma. Visna M. Manio (Bureau of Maintenance)
4. Archt. Tessa E. Salinas (Project Management Office-Special Buildings)

All expenses to be incurred in these activities and the honoraria/allowances of the personnel involved shall be charged against any appropriate funds of the Department, subject to the usual accounting and auditing rules and regulations.

This Order supersedes previous issuances inconsistent herewith and takes effect immediately.
