The NBCRC shall undertake the following continuing and proposed activities:

 Review and take action on issues and concerns of different professional technical organizations relative to the National Building Code (NBC) and its Implementing Rules and Regulations (IRR);

- 2. Review and recommend approval on the proposed revision/amendment of the Implementing Rules and Regulations (IRR) of the National Building Code of the Philippines (PD 1096) submitted by the NBC Board of Consultants;
- 3. Study of the proposed amendments to PD 1096; and
- 4. Preparation of recommendations to Congress in aid of legislation.

All expenses to be incurred in these activities including the honoraria/allowances of the personnel involved shall be properly charged against any available funds of the Department, subject to the usual accounting and auditing rules and regulations.

This Order supersedes previous issuances to the contrary and shall take effect until the completion of the aforesaid activities.
