SUBJECT: Reconstitution of the Board of

**Consultants of the National Building
Code**

The Board of Consultants (BOC) of the National Building Code of the Philippines (PD 1096) which was organized through Special Order No. 1, dated 01 April 1996 and reconstituted through Special Order No. 5 dated January 5, 2006 for the purpose of updating/amending the Implementing Rules and Regulations (IRR) of the Code is hereby further reconstituted as follows:

The BOC shall undertake the following continuing and proposed activities in coordination with the National Building Code Development Office (NBCDO)

1. Review of the existing Implementing Rules and Regulations (IRR) in pursuance to PD 1096 and recommend necessary amendments thereof;
2. Preparation of Handbook on the Implementation and Enforcement of the National Building Code (NBC) and its Implementing Rules and Regulations (IRR);
3. Conduct of seminar and workshop on the National Building Code and its Implementing Rules and Regulations;
4. Review of the existing National Building Code Circulars and other related issuances of the Department and recommend appropriate amendments thereof;
5. Review on the rules on Advertising Signs and Signages, including billboards, and its effect on the environment during typhoons and other calamities; and
6. Evaluation of National Building Code cases and inquiries.

All expenses to be incurred in these activities and the honoraria/allowances of the personnel involved shall be charged against any appropriate funds of the Department, subject to the usual accounting and auditing rules and regulations.

All existing orders/issuances inconsistent herewith are thereby revoked/repealed.
