The TWG shall submit to the MANCOM the refined draft Department Order for the Officials Delegated Limits of Authorities in Matrix Format on 15 November 2006.

The TWG shall identify the delegated authorities that require an Implementing Guidelines such as the checklist and supporting documents, update of forms/title blocks of plans, processes/flowcharts and etc. The TWG is mandated to require immediately the concerned Officials to submit relevant documents in drafting the Department Order for the Implementing Guidelines and submit to MANCOM not later than 29 November 2006.
