In the interest of the service, and consistent with Republic Act No. 9184 entitled The Government Procurement Reform Act and its Implementing Rules and Regulations, Part A (IRR-A), the composition of the Central Office Bids and Awards Committee (BAC) for Consultancy Services is as follows:

The functions of the BAC for Consultancy Services shall be in accordance with the relevant provisions of Republic Act No. 9184. It shall continue the unfinished business of the erstwhile BAC for Consultancy Services using applicable procurement guidelines.

The Regular Members of the BAC for Consultancy Services shall have a fixed term of one (1) year reckoned from the date of appointment, renewable at the discretion of the Secretary. In cases of resignation, retirement, separation, transfer, reassignment, removal, or death, the replacement shall serve only the unexpired term.

The following shall be invited as observers, who shall sit in and monitor proceedings of the BAC for Consultancy Services as Non-Voting Members:

- (a) One (1) Representative from the Commission on Audit (COA)
- (b) One (1) Representative from the Confederation of Filipino Consulting Organization
- (c) One (1) Representative from a Non-Government Organization (NGO)

The BAC for Consultancy Services shall be assisted by the existing Secretariat that shall serve as the BAC for Consultancy Services' Secretariat and Technical Working Group (TWG) and have the functions and responsibilities prescribed in the IRR-A of RA No. 9184 and perform other such functions as maybe directed by the Chairman.

All expenses to be incurred including the honoraria/allowances of the personnel involved shall be properly charged against any available funds of the Department, subject to the usual accounting and auditing rules and regulations.

Any and all existing Special Orders and other issuances inconsistent herewith are hereby repealed accordingly.

This order takes effect immediately.
