The NBCRC shall undertake the following tasks:

- 1. Evaluate and recommend action on issues and concerns of different professional technical organizations relative to the National Building Code of the Philippines (PD 1096) and its Implementing Rules and Regulations (IRR);
- 2. Review and recommend approval of proposed revisions/amendments to the IRR of the Code submitted by the National Building Code Development Office (NBCDO) and the National Building Code of the Philippines-Board of Consultants (NBCP-BoC);
- 3. Review proposed amendments to PD 1096 and prepare recommendations to Congress in aid of legislation.

All expenses to be incurred in these activities and the honoraria/allowances of the NBCRC Members, its TWG and Secretariat Members and DPWH personnel involved shall be charged against any appropriate funds of the Department, subject to the usual accounting and auditing rules and regulations.

This Order supersedes S.O. No. 46, Series of 2016, and shall take effect immediately.
