**SUBJECT: Updating of Rule XX-Signs
and Conduct of Seminar/

The aforementioned personnel shall undertake the following continuing activities in coordination with the National Building Code Development Office (NBCDO):

1. Review/updating of the provisions of Rule XX-Signs, Revised IRR of PD 1096 which shall serve as the guidelines on outdoor advertising signs/billboards;
2. As the original framers of the revised IRR of PD 1096, assist the incoming BoC members in the review of the existing IRR in pursuance to PD 1096 and recommend necessary amendments thereof;
3. Assist in the preparation of Handbook on the Implementation and Enforcement of the National Building Code and its implementing Rules and Regulations;
4. Conduct of seminar/workshop on the NBC and its IRR until such time that the incoming BoC shall convene to select a new set of resource persons therefrom; and
5. Assist in the evaluation of NBC cases and inquiries.

All expenses to be incurred in these activities and the honoraria/allowances of the personnel involved shall be charged against any available funds of the Department, subject to the usual accounting and auditing rules and regulations.

This order shall serve as an addendum to said S.O. No. 91 and shall take effect immediately.
