The DPWH Task Force "Baklas Billboards" shall ensure effective implementation of the provisions of the National Building Code of the Philippines (PD 1096), Administrative Orders 160 and 160-A, both series of 2006, and memorandum dated 03 January 2014 nationwide. The Task Force shall submit report to the undersigned the activities/works accomplished, actions taken and proposed recommendations/measures, for monitoring purposes and to ensure compliance with the law and issuances on billboards, thru the National Building Code Development Office (NBCDO).

THE Task Force shall be assisted by a Secretariat to be composed of personnel from the National Building Code Development Office (NBCDO).

The expenses necessary for this undertaking shall be charged against appropriate funds of the Department, subject to the existing accounting and auditing rules and regulations.
