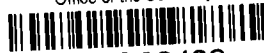
A Technical Working Group (TWG) is also hereby constituted to undertake the preliminary evaluation of the qualification documents and bids and shall submit the results to the aforementioned Special BAC for review and recommendation to the Secretary. The TWG shall compose of the PPP Service as Head, and a representative each from PPP Service,

BOD, BOC, FMS, Legal Service and Planning Service- Project Preparation Division. The SBAC may invite other offices when necessary. The PPP Service shall act as Secretariat to the BAC.

This Order amends Special Order No. 43 Series of 2013 and shall take effect immediately.
