SUBJECT: CREATION OF A TECHNICAL WORKING GROUP (TWG) FOR THE FINALIZATION OF JOINT MEMORANDUM CIRCULAR (JMC): GUIDELINES ON THE ISSUANCE OF CLEARANCE AND/OR PERMIT FOR DREDGING

In order to ensure the systematic review and immediate finalization of the proposed Joint Memorandum Circular (JMC): Guidelines on the Issuance of Clearance and/or Permit for Dredging among Department of Environment and Natural Resources (DENR), Department of the Interior and Local Government (DILG), Department of Transportation (DOTr) and this Department, a Technical Working Group (TWG) shall be created for this purpose and shall be composed of the following:

The TWG shall have the following functions:

- a. Review/evaluate the proposed JMC and compare all inter-agency policies regarding/covering dredging clearances and/or permit
- b. Conduct meetings/workshops to discuss comments/suggestions on proposed JMC
- c. Coordinate and collaborate with the concerned agencies of the DENR (i.e., MGB, EMB), DILG and DOTr for the convergence of the provisions of the JMC
- d. Prepare the final draft of the JMC Guidelines on the Issuance of Clearance and/or Permit for Dredging for approval and signature of the concerned Department Secretaries.

The TWG may invite other DPWH officials/personnel or other concerned agencies and entities to participate and/or provide assistance in the finalization of the JMC, as the need arises.

This Order shall take effect immediately.
