3. Conduct orientation on the RPF, RAP, Grievance Mechanism and Monitoring.
4. Assist the Resettlement Team Consultants in the tagging/delineation of affected areas/Cost Estimates/FGDs/Consultation Meetings with Project Affected Persons (PAPs); and
5. Disclosure of and process payment of compensation package.
