Pursuant to RA 9184 – Annex G: Guidelines for the Procurement and Implementation of Contracts for Design and Build Infrastructure Projects, the DBC shall assist the project management office (PMO) in the preparation of the conceptual design and performance specifications and parameters, review of detailed engineering design and supervision of the project. It shall, likewise, support the Bids and Awards Committee (BAC) and the Technical Working Group (TWG) in the evaluation of technical proposals in accordance with the criteria set in the Bidding Documents.

The DBC shall perform the following tasks and functions:

Chairperson

shall provide the over-all supervision and guidance for the project implementation, specifically for the Design Review and Supervision activities to ensure that implementation is carried out in accordance with the objectives of the Department

**Assistant Chairperson** 

shall assist the Chairperson in the over-all supervision and guidance for the project implementation, specifically for the Design Review and Supervision activities to ensure that implementation is carried out in accordance with the objectives of the Department

shall coordinate meetings among members of the Committee

Representative, Bureau of Design

shall be responsible for the review and evaluation of project designs and plans to ensure these are in accordance with standard specifications

shall conduct periodic review (as maybe required) of the project designs to assess its technical suitability to actual field conditions

Representative, Bureau of Construction

shall be responsible for the technical review of the Agency Estimates (POW and ABC), PERT/CPM, Bar Chart carried out in accordance with the standards and guidelines set forth by the department and shall see to it that these are facilitated for its timely approval, inclusive of time suspension/extensions, applied variation orders and other project documents relative thereto as maybe needed from time to time

shall perform periodic monitoring of project implementation to ensure that method of construction/technical standards are done in accordance with standard specifications and guidelines set by the department S.O. Representative, Bureau of Research and Standards

shall be responsible for the necessary review/evaluation of new pay items introduced for the satisfactory completion of the project and facilitate timely approval of the same.

Shall perform periodic monitoring of the project's implementation as maybe deemed necessary to ensure that quality technical standards are met and guidelines are followed

Representative, Finance Service

shall facilitate all financial concerns pertaining to this project as deemed necessary and shall be responsible in providing timely payments of physical accomplishments and other claims

Representative, Planning Service

shall provide adequate fund support for the timely completion of the project

shall provide support to monitor compliance with the Environmental Management Plan and Safeguard issues.

Representative, Procurement Service

shall carry out the procurement of the Design and Build Contract in accordance with the guidelines of Annex G and the IRR of RA 9184

Project Manager/Engineer

shall be the over-all field supervisor under the guidance of the Project Director and shall monitor the project implementation

shall be responsible in providing timely consolidated project implementation bi-monthly status report to the Chairperson, thru the Assistant Chairperson

shall conduct periodic evaluation of the project's physical accomplishments, and recommend appropriate action for the timely completion of project implementation

shall be responsible in ensuring that project is completed within the committed time frame

shall monitor the Road Right-of-Way acquisition in accordance with RA 10752 as provided by law.

The DBC, through the Implementing Office (IO) shall coordinate the implementation of the Design and Build Scheme among the representatives of relevant organizations/agencies, LGUs, and other stakeholders, as the need arises.
