The Career Executive Service Board will hold the 51<sup>st</sup> Founding Anniversary and 2024 CESCON from 5 to 6 November 2024 at the Philippine International Convention Center, with the theme "*Pag-ibig sa Bayan, CESerbisyong may Dangal.*"


In view thereof, all CES officers, eligibles, and on-stream candidates for CES eligibility are authorized to attend the 51<sup>st</sup> Founding Anniversary and 2024 CESCON on official time, provided that this will not hinder the operations of their respective offices as well as the delivery of essential services to the public.

Expenses to be incurred by the participants shall be allowed at prescribed rates, in accordance with the existing policies of the Department of Budget and Management and the Commission on Audit.
