Pursuant to Sec. 69.1 (i) Rule XXIII of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, and in accordance with Department Order No. 28 series of 2024, this Suspension Order is hereby issued against **DAVE CONSTRUCTION**.

Based on the Approved Consolidated Three (3)-Strike Report, dated February 19, 2025, and posted on the DPWH Intranet on February 28, 2025, this contractor/supplier, bearing the PhilGEPS Registration No. 201610-187698-1962338808 and located at Brgy 5, San Francisco, Agusan del Sur, Caraga, has incurred three (3) strikes/offenses within a year from the approval date of the Resolution Recommending the Imposition of Strike One - First Warning.

DAVE CONSTRUCTION is disqualified from participating in any DPWH bidding processes, effective immediately upon receipt of the Notice of Suspension. This suspension shall remain in effect during any period of reconsideration or appeal until a final decision is rendered by the Office of the Secretary. However, this suspension does not apply to the contractor's participation in procurement activities of other government agencies.

This Order shall take effect immediately.
