SUBJECT: **Creation of the DPWH Alternative
Dispute Resolution (DAD-R)
Committee**

In order to attain the government policy of updating, harmonizing and improving the Philippine legal framework to strengthen the use of Alternative Dispute Resolution (ADR), this Department, in adherence to the mandatory requirements enumerated under Republic Act (RA) No. 9285¹, its Implementing Rules and Regulations (IRR)², Executive Order Nos. 78³ and 97⁴, both series of 2012, and Presidential Decree No. 242⁵ as amended, hereby creates the DPWH Alternative Dispute Resolution (DAD-R) Committee.

The Committee shall be composed of the following:

The primary functions of the DAD-R Committee shall include the following:

1. Create, craft, and submit ADR Department-wide Programs in accordance with the specific mandate of the Department, for the approval of the Secretary;
2. Creation of an ADR System;
3. Creation of ADR Procedures;

4. To recommend and submit guidelines, policies and/or issuances for the approval of the Secretary;
5. To harmonize and/or recommend the harmonization of the ADR Programs, Policies, and/or Guidelines in accordance with existing DPWH Policies, Guidelines, and/or Issuances;
6. To propose the improvement of ADR Programs and Policies;
7. Manage, develop, coordinate, and oversight of the established ADR Programs;
8. Monitor, in accordance with EO No. 97, series of 2012, the mandatory annual submission of periodic reports to the DOJ-Office of Alternative Dispute Resolution (OADR);
9. Coordinate with the OADR for the institutionalization of the DPWH ADR System to assist the Committee in its functions;
10. Create a Technical Working Group (TWG) that specializes in each ADR System to assist the Committee in its functions;
11. Convene, from time to time, in order to serve the purpose of this DO; and
12. Such other functions as may be deemed necessary or incidental in the implementation of the said laws, orders, or issuances.

This Order shall take effect immediately.
