**SUBJECT: Issuance of Suspension Order  
to STEVEN CONSTRUCTION  
AND SUPPLY**

Pursuant to Sec. 69.1 (i) Rule XXIII of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, and in accordance with Department Order No. 28, Series of 2024, this Suspension Order is hereby issued against **STEVEN CONSTRUCTION AND SUPPLY**.

Based on the Approved Consolidated Three (3)-Strike Report, dated April 8, 2025, and posted on the DPWH Intranet on April 29, 2025, this contractor, bearing the PhilGEPS Registration No. 200403-3249-1180540101 and located at Lot 6, Blk. 1 Central City Subd. Tahao Rd. Legazpi City, Region V), has incurred four (4) strikes/offenses within a year from the approval date of the Resolution Recommending the Imposition of Strike One - First Warning. While the specific sub-offense categories vary among Implementing Offices (District Engineering Offices) - namely, (i) submission of an expired Certificate of PhilGEPS Registration (Platinum Membership), and (ii) submission of incomplete, insufficient, or defective documents due to non-inclusion and/or omission of mandatory provisions and statements for the required bid forms - all four (4) violations fall under the main strike offense category of "Submission of Patently Insufficient Bid."

The detailed offenses are as follows:

STEVEN CONSTRUCTION AND SUPPLY is disqualified from participating in any DPWH bidding processes, effective immediately upon receipt of the Notice of Suspension. This suspension shall remain in effect during any period of reconsideration or appeal until a final decision is rendered



by the Office of the Secretary. However, this suspension does not apply to the contractor's participation in procurement activities of other government agencies.
