Pursuant to Sec. 69.1 (i) Rule XXIII of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, and in accordance with Department Order No. 28 series of 2024, this Suspension Order is hereby issued against **CORLEONE CONSTRUCTION SERVICES**.

Based on the Approved Consolidated Strike Report, dated April 30, 2024, and posted on the DPWH Intranet on May 10, 2024, this contractor, bearing the PhilGEPS Registration No.202107262908667125088 and located at Panggao Saduc, Marawi City, with a sub-office at Block 11, Lot 18, Erlinda Village, Del Carmen, Iligan City, is found to have committed three (3) or more strikes/offenses of a similar or identical nature within a year, starting from the approval date of the Resolution Recommending the Imposition of Strike One - First Warning.
