(3) Additional Road Sections (Wye Length) or Transition Lanes Under the Jurisdiction of Ilocos Norte 2nd DEO, Region I


In order to maintain the correctness and quality of information in the Road and Bridge Information Application (RBIA) in accordance with D.O. No. 124, series of 2016, the renaming of the following road sections are hereby adapted and implemented in the RBIA under the purview of Ilocos Norte 1st and 2nd District Engineering Offices (DEOs), Region I

Furthermore, supplementary road segments, constructed as wye lengths to serve as transition lanes for vehicles from their respective road sections, will be incorporated as an additional segment within the road network of Ilocos Norte 2nd DEO, as follows:

Gaang Wharf Road (Wye Length)	34
Manila North Road (Wye Length)	49
MNR Jct-Baay-Suba Road (Wye Length)	54

Pias-Currimao-Balacad Road (Wye Length)	52
